"A RESOLUTION SUPPORTING THE PETITIONERS IN THEIR QUEST FOR CLIMATE JUSTICE ,AND REQUESTING THE COMMISSION ON HUMAN RIGHTS TO ORDER FORTY SIX (46) LARGEST GREEN HOUSE GAS PRODUCER CORPORATIONS TO SUBMIT THEIR PLANS ON THE STEPS THEY WILL UNDERTAKE TO ELIMINATE ,REMEDY AND PREVENT THE DEVASTATING EFFECTS OF CLIMATE CHANGE IN THE PHILIPPINES, AND FURTHER SUPPORTING THE COMMISSION ON HUMAN RIGHTS ON THEIR INVESTIGATION IN RELATION THERETO"

WHEREAS, Article II, Section 15 of the 1987 Constitution provides, "The State shall protect and promote the right to health of the people and instill health consciousness among them."

WHEREAS, Article II, Section 16 of the 1987 Constitution provides, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature.";

WHEREAS, the Islamic City of Marawi believes that a healthy environment and a balanced ecology is one of the key pillars to a productive humanity;

WHEREAS, the Islamic City of Marawi is committed to preserve its natural

WHEREAS, the Sangguniang Panlungsod of the Islamic City of Marawi is cognizant of the landmark climate change and human Rights Petition filed by Greenspace Southeast Asia and Philippines Rural Reconstruction Movement ,together With twelve (12) non- profit organizations and eighteen (18) individuals (collectively referred hereinafter as the Petitioners "), before the commission on human Rights requesting for an investigation on the responsibility of forty six (46) multinational fossil fuel and cement companies (carbon Majors for human rights violation or threats of violations resulting from the impacts of climate change);

WHEREAS, the commission on human Rights is currently conducting a national inquiry regarding the aforementioned climate change and human Rights Petition;

NOWTHEREFORE, upon motion of HON. FARHANNA P. LANGCO, duly seconded by all SP Members, it was;

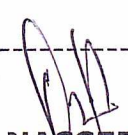

RESOLVED FURTHER, to furnish copies of this Resolution to all concerned offices for their information, guidance and implementation.

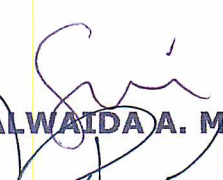
